## **Terms of Sale:**

#### 1. Deposit:

- A non-refundable deposit of \$300 USD is required to hold the kitten. Full payment is due before delivery or pick-up.

#### 2. Health Guarantee:

- The kitten is guaranteed to be in good health at the time of sale. The buyer has 72 hours to take the kitten to a licensed veterinarian for a health check. If any *non-curable health issues* are found (e.g., genetic defects, chronic illness), the breeder must be notified immediately for a possible return or replacement.

#### 3. Return Policy:

- If, for any reason, the buyer cannot keep the kitten, they must return the kitten to the breeder. No refunds will be given, but the breeder will assist in rehoming the kitten.

#### 4. Spay/Neuter Agreement (For Pet Only):

- If the kitten is sold as a pet, the buyer agrees to have the kitten spayed/neutered within 1 month of the kitten being in their new home. Proof of spay/neuter must be provided to the breeder.
- **Failure to spay/neuter:** If the buyer fails to provide proof of spay/neuter within 1 month, they will owe an additional \$2,000 for violating this agreement.

#### 5. Liability:

- The breeder is not responsible for any medical costs or damages after the kitten leaves the breeder's care, except as stated under the health guarantee.
